STANDARDS FOR HACKNEY CARRIAGE VEHICLES

<u>Submitted by:-</u> Head of Business Improvements, Central Services and Partnerships.

Purpose

To bring to the attention of the Committee the standards of maintenance of Private Hire and Hackney Carriage vehicles licensed by this authority.

Recommendation

That the report be received

Background

The recent decision to amend the age policy on wheelchair accessible Hackney Carriages resulted in a rash of applications by applicants taking advantage of the then 10 year rule.

The Licensing Department has been notified by the Council's Engineer responsible for testing vehicles of his concerns regarding the poor condition and low standards of maintenance of vehicles presented for both initial testing and for subsequent annual tests.

A study of the test result from 1st July 2013 to the 31st December 2013 reveal that a total of 303 vehicles had been tested, of those 120 passed the test with no failures of the remainder 60 vehicles failed the test with what would be described as minor failures, the remaining 123 failed the test for could be classed as major failures, this would be for items including, steering, suspension, braking system, tyres and wheels. To sum up of the 303 vehicles tested 60% failed the test.

<u>Issues</u>

The Council have a duty to protect the public and to ensure that any vehicles licensed as either Private Hire of Hackney Carriages are safe and comfortable.

Further, the Council attaches conditions to its vehicles licences which require the holder of the licence to ensure that:-

"The vehicle and all its fittings and equipment shall at all times when the vehicle is in use or available for hire, be kept in an efficient, safe, tidy and clean condition, and all relevant statutory requirements (including in particular those contained the Motor Vehicles Construction and Use Regulations), shall be fully complied with".

Actions

Officers from the Operations Department, the Licensing Department and Environmental Health are working co-operatively to address the problem of the poor condition and poor maintenance standards of vehicles within the Council's fleet. It

can be anticipated that further reports on this matter will be presented to the Committee when available.
