# Supplementary report in relation to Hackney Carriage and Private Hire Vehicle Fees

New legislation has come in to force since the original fee structure was proposed which amends the Miscellaneous Provisions Act 1976 in relation to the duration of licences for hackney carriage and private hire drivers and private hire operators.

Section 10, subsection 2 of the Deregulation Act 2015 changes the law in such a way as to establish a standard duration of three years for hackney carriage and private hire driver licences. The section specifies that a licence may be granted for a period of less than three year but only in circumstances of an individual case, not because of a blanket policy.

Subsection 3 of the Act changes the law in such a way as to establish a standard duration of five years for a private hire vehicle operator licence. The section specifies that a licence may be granted for a period of less than five years but only in the circumstances of an individual case, not because of blanket policy.

The original table regarding the recommended fees for 2016/2017 has been updated below to reflect the changes in the legislation:

To investigate complaints and to confirm vehicles are fit the Chief Executive, Executive Director Regeneration & Development or Executive Director Operational Services may authorise in writing officers to:

- a) Require provision of information and production of documents Hackney Carnages and private hire vehicles Sect. 50, 53 & 56;
- b) Ensure the return of identification plate or disc on revocation or expiry of licence etc., Sect.58; and
- c) undertake the Inspection and Testing of Hackney Carnages and private hire vehicles for fitness. Sect. 68.

In the event that authorised officers are obstructed (Sect 73), a report will be brought to Public Protection seeking permission to commence proceedings (Sect 76)
