### 1. **APOLOGIES**

An apology was received from Councillor Naylor.

### 2. **MINUTES OF PREVIOUS MEETING**

**Agreed:** That the minutes of the meeting held on 5 July 2017 be accepted as a correct record.

#### **Matters arising:**

**Quarterly Meeting with the Clinical Commissioning Group (CCG):** Notes of the meeting held on 4 October with Anna Collins, Head of Communications and Engagement and Lorna Clarson, Clinical Director Partnership and Engagement at the CCG together with the Chair of the Active and Cohesive Scrutiny Committee and the Chair of this were circulated for information.

The main themes being:

1. Pre-Consultation Events, based on the 5 community hospital areas would take place up to the end of December to look at what health services need to be provided and from where.
2. A Care Navigation programme was being developed to ensure that people who contacted their GP were sign posted to the right services.
3. Community Conversation aimed at giving people the opportunity to talk about how health services for older people are commissioned.
4. Medicines Matter campaign to reduce the amount of prescribed but unused medicines.

5. One Governance Structure (Board) is to be adopted for all six CCG's resulting in efficiency savings.
6. Social Prescribing - NHS Staff trained to undertake enhanced roles in active signposting and supporting community referrals to local non clinical services.
7. Research at Keele University to support decision making on the treatments and services commissioned for patients based on evidence about what works best. Non clinical services such as the programmes at Jubilee2 were identified for further discussions regarding the Borough Councils involvement in establishing a robust evidence base for both current and planned programmes.

Members welcomed engagement with the CCG and a member requested specific feedback in respect of the progress of the Care Navigation programme.

**Dementia Friendly Swimming:** The Scrutiny Officer reported on the decision of Cabinet (26/09/17) to approve the development of an appropriate action plan to implement Dementia Friendly Swimming at Jubilee2, within existing resources and in partnership with appropriate local partners.

3. **DECLARATIONS OF INTEREST**

Councillor Wilkes stated that, in relation to the Space Programme, he was willing to offer vouchers at nil profit for use by the scheme in respect of the archery programme which he managed.

4. **HEALTHY STAFFORDSHIRE SELECT COMMITTEE MINUTES 18 SEPTEMBER**

**Agreed:** That the minutes of the Health Staffordshire Select Committee held on 18 September 2017 be received.

5. **EVALUATION OF THE SPACE PROGRAMME 2017**

The Partnerships Manager and the Sports and Active Lifestyles Manager presented an evaluation of the 2017 Space Programme which had received funding from the Police and Crime Commissioner (PCC) in respect of positive activities for young people between 11-17 year olds, encouraging positive engagement and helping to reduce anti-social engagement.

In terms of participation from the Borough 702 universal places had been offered together with 115 targeted places referred from the Local Support Team (LST) or the Anti-Social Behaviour Team.

The total funding of £16,200 allocated by the Service Commissioner to local activities included £1,000 contribution from the Joint Operations Group, £2,000 from the LST and £2,400 from Stoke City Football Club.

A member asked for information on how well young carers had accessed the scheme and it was explained that this information was not available from the data collected. The Sports and Active Lifestyles Manager did feel however that there was a possibility, through partnership working, to help to support young carers to access

the scheme and in this respect the member suggested that the North Staffs Carers Association would be a useful source of information.

Reflecting on the age range and the need to engage early the Partnerships Officer felt that it would be beneficial for the scheme to encourage participation from 8-11 year olds.

PCC feedback on the outcomes from the scheme had been very positive and, in this respect a member wished to see the outcomes reflected in data e.g. KPIs.

**Agreed** That the report be received.

**6. WORK PROGRAMME**

A member expressed concern at the narrow scope of the current work programme and, continuing, referred to the report of the 4 October meeting with the CCG in respect of governance arrangements the changes to adult social care which was the responsibility of the SSOTP and to the winter pressures on the Royal Stoke Hospital which had been reported in the local press. It was generally agreed that members wished to ask these organisations to attend future meetings of the Committee.

Specifically in relation to The Royal Stoke Hospital members requested a representative attend a future meeting to discuss the following issues:-

Is The Royal Stoke Hospital achieving timely discharge for residents of Newcastle under Lyme?

If there are delays what is the cause?

Do the residents of Newcastle under Lyme experience any delays in relation to operation waiting times?

<p><b>Strategic Collaboration between Burton Hospitals NHS Foundation Trust and Derby Teaching Hospitals NHS Foundation Trust – Outline Business Case- Follow-up</b></p> <p>They considered a joint report of the Chief Executives of Burton Hospitals NHS Foundation Trust and Derby Teaching Hospitals NHS Foundation Trust and received a presentation updating them on progress with regard to their proposals for greater strategic collaboration through the acquisition of Burton Hospitals NHS Trust by the Derby Trust.</p> <p>Members learned that since their previous meeting with the Trusts they had prepared a Patients' Benefits Case setting out the anticipated clinical benefits of the proposals together with the risks from a no-change scenario. The specific service areas which had been highlighted as benefiting from the merger included hyper-acute stroke, cardiology, renal medicine, radiology and orthopaedics.</p> <p>During the meeting, Members gave detailed scrutiny and sought clarification of the Trusts' plans specifically relating to (i) the impact on staff recruitment and retention; (ii) their ability to treat more patients locally; (iii) the future of Community Hospitals in Lichfield and Tamworth; (iv) Staffordshire's representation on the combined Trust's Board; (v) the co-ordination between the</p>	<p>East Staffordshire Borough Council; Lichfield District Council and; Tamworth Borough Council</p>

<p>Trust and specifically the Staffordshire and Stoke-on-Trent Sustainability and Transformation Partnership and; (vi) the measures being implemented to ensure a smooth organisational change.</p> <p><b>University Hospitals North Midlands NHS Trust – Action Plans and Progress</b></p> <p>They received an oral report from the Chief Executive of University Hospitals North Midlands NHS Trust regarding their efforts to achieve financial sustainability following being placed into Financial Special Measures by the NHS Improvement in March 2017. Members learned that whilst the Trust previously had one of the largest NHS deficits in the Country at £119m, the anticipated outturn position for the current year was £70m.</p> <p>The Trust had a Financial Recovery Plan in place together with a refreshed 2025 Vision. However, various external factors were contributing to on-going planned deficits including (i) long standing structural issues in the wider health economy; (ii) delays in the receipt of payments from Clinical Commissioning Groups and; (iii) the end of Transitional funding to support the re-configuration of the acute sector on north Staffordshire.</p> <p>The Committee asked the Chief Executive to attend their meeting in March 2018 to update them on progress with regard to the Plan.</p>	<p>Newcastle-under-Lyme Borough Council; Staffordshire Moorlands District Council and; Stafford Borough Council</p>

Timeliness of discharge and why the delays

The profile of discharges for RSUH is in keeping with the national average, so c22% of patients leave RSUH by midday, the national range is between 10%-30%. However, some Stoke on Trent residents can wait many days, several weeks in fact from being medically optimised to actually leaving the building. At the time of writing this RSUH has 150 medically fit for discharge patients, at its lowest it has been 115 (April) and has been as high 220 in November (this includes patients from Staffordshire, currently being treated in RSUH to). The reasons are many and varied, but the key delay relates to care package availability and delays for assessment beds, re-hab beds and EMI beds, again those beds in the community are also requiring care package capacity to ensure timely outflows. At the time of writing this the division of medicine, which has c500 beds on the RSUH site currently has just short of 100 patients who are Medically fit for discharge.

Waiting times for Stoke on Trent residents for operations.

Several individual specialties are compliant against the national 18 week standard, but from an overall Trust UHNM is currently not compliant with the national 18 week referral to treatment standard, currently UHNM is treating 77% of its patients within 18 weeks against a standard at 92%, we currently also have c20 patients how have breached the 52 week backstop standard.

### Dementia Friendly Activities in Newcastle-under-Lyme

#### Introduction

Dementia is acknowledged to be a major health & wellbeing issue that provides many challenges that are best met by working in partnership.

In 2010 the National Dementia Declaration for England led to the establishment of the national Dementia Action Alliance (DAA) co-ordinated by the Alzheimer's Society.

Locally the Staffordshire & Stoke on Trent DAA meets quarterly and brings a range of partners together to co-ordinate Dementia Friendly activities and projects. Newcastle Borough Council is an active member of Staffordshire & Stoke on Trent DAA.

#### Background

A Joint Meeting of Health & Wellbeing Scrutiny and Active & Cohesive Scrutiny Committees held on Wednesday 5<sup>th</sup> July 2017 received a presentation on Dementia Friendly initiatives in the Borough from Will Boyce, Chief Officer of Approach and Chair of the Staffordshire & Stoke-on-Trent Dementia Action Alliance (DAA).

Following that it was agreed that the Partnerships Locality Officer and the CEO of Approach, Mr Will Boyce compile a data base of dementia friendly facilities and activities within the Borough to be presented to Health & Wellbeing Scrutiny meeting to be held on 10<sup>th</sup> January 2018.

#### Questions to be Addressed

- 1) How does the information contained in the data base inform Scrutiny about dementia provision in the Borough?

- 2) How are dementia services in the Borough monitored to ensure, as far as reasonably possible, that needs are being met?

### **Outcomes**

- 1) Scrutiny consider the data base that has been produced and advise as to what further action is required thereof to provide the information contained in a user friendly and informative manner.
- 2) Scrutiny to receive regular updates from both Council officers and the Staffordshire & Stoke-on-Trent DAA.

### **Supporting Information**

Further to the aforementioned meeting held on 5<sup>th</sup> July 2017 a data base has been produced in Spreadsheet format with an emphasis on partnership activities & projects. The information contained does not, and cannot, claim to be fully comprehensive; it does not, for example, include the plethora of residential care and nursing homes whose residents will include people with dementia.

# DEMENTIA ACTION ALLIANCE – ANNUAL UPDATE SUBMISSION

## ARTS, CULTURE, LEISURE AND RECREATION

Work commenced with dementia friends/dementia awareness sessions involving the following organisations:

Port Vale Football Club.

Stoke City Football Club - match day respite, reminiscence, accessible room and tours, and walking football. Stoke are the first Premier Club to sign up to the DAA in the country.  
Tamworth Hockey and Cricket Club.

Jubilee Swimming Baths - Newcastle, Staffordshire - working towards offering dementia friendly swimming sessions.

Swimming Pool in East Staffs area - dementia friendly swimming sessions.

Private Golf Club in East Staffs area - looking at developing a dementia friends buddying system.

Biddulph Leisure Centre.

New Vic Theatre - Newcastle - Staffordshire - early conversations around commencing some work.

Garrick Theatre - East Staffordshire - setting up a Dementia Café and in the process of signing up to the DAA.

Regent Theatre - Hanley - Stoke-on-Trent - held a "relaxed" performance last Christmas of the pantomime; talks to be initiated with them around dementia.

Stoke-on-Trent Libraries - a number of dementia friends session held for library staff across a number of city libraries. Reminiscence Pod set up at Hanley Library and to move around the city libraries. Public Dementia Friends session held at Hanley Library and well attended.

Brampton Museum - Newcastle, Staffordshire, work in early phases to introduce dementia.

Emma Bridgewater Pottery - Stoke-on-Trent. Held a Dementia Friends session for staff.

Cheadle Guildhall - host Singing for the Brain in regular six weekly blocks.

## BUSINESSES AND SHOPS

Marks and Spencer - Wolstanton - Newcastle - Dementia Friends sessions held with staff as well as a dementia awareness session held for the public in the foyer area. Looking at incorporating this into the new staff induction process. Offered their community room for training sessions and considered the environment of the shop for people living with dementia.

Tesco - Hanley - Stoke-on-Trent - held dementia awareness raising and hosted the Alzheimer's Bus for a day.

Various Wilkinson stores across Staffordshire- some held Dementia Friends sessions; previously the Alzheimer's Society chosen charity of the year.

Sainsbury's - Tamworth - Staffordshire - have signed up to the DAA.

Talks with Morrisons, Tamworth, commenced about signing up to the DAA and this is progressing.

Sainsbury's - Stafford - Choices Housing to deliver Dementia Friends sessions.  
TSB - Hanley - awareness sessions held.

Stoke City Council - sessions held for some staff teams and Members; Dementia Friendly Communities Ambassador established - Councillor Melanie Baddeley who supports and promotes this work.

Newcastle Borough Council - sessions held for some staff teams and Members involved with the Health and Social Care Scrutiny Committee. Further sessions planned. Signed up to DAA.

East Staffordshire Borough Council - held Dementia Friends session for some teams of staff.  
Cannock Borough Council - held Dementia Friends sessions for some teams of staff.  
Staffordshire County Council - held Dementia Friends sessions for some teams of staff.

Tamworth - market stall awareness raising event.

Wolstanton High Street - Newcastle - Staffordshire - businesses and organisations signing up to DAA as a collective group - awareness raising events held.

Audley High Street - looking to sign up to the DAA and setting up of dementia friendly communities.

Vodafone - Dementia Awareness training for staff.

## **CHILDREN, YOUNG PEOPLE AND STUDENTS**

Working with a number of schools (around 20) across Staffordshire and Stoke-on-Trent. Three have signed up to the DAA, including Gladstone Primary School who were the first primary school in the West Midlands to sign up and, as a result, were featured on BBC Midlands Today in December 2016 on the work being taken forward at the school and benefits of it. Other schools are earlier on in the process and have had, or are having shortly, dementia friends sessions and looking to introduce the topic of dementia into the curriculum. Commissioners supporting and encouraging this work.

Initial conversations with Keele University - Newcastle - Staffordshire - to be progressed but sessions have been delivered to the University's counselling team.

Staffordshire University - Dementia Friends session delivered as part of the Citizens Course.

Staffordshire College - May 2017 - Dementia Friends sessions delivered to Level 3 students.



Tamworth - Staffordshire - special dementia friends resources developed for delivery to Year 5 pupils during a week called "safety town" to promote dementia across the area.

Wolgarston School - Tamworth - have had a Dementia Friends session.

A workshop with other schools has been held and some are now enquiring how they can progress this further.

Kingsland Primary School - Stoke - Staffordshire - Lichfield Diocese working with the school to develop some work around understanding dementia for pupils.

## **COMMUNITY, VOLUNTARY, FAITH GROUPS AND ORGANIZATIONS**

Working with Lichfield Diocese. Dedicated appointed workers to promote dementia awareness. Developed a strategy for embedding dementia friendly churches, created a bi monthly newsletter, supporting churches to become more dementia friendly and delivering dementia friends sessions in churches. Looking to appoint dementia friendly co-ordinators in each church to pray with and signpost accordingly.

St Barnabas, Tillington, Stafford, ran a dementia café, and holds specific dementia friendly services ahead of the café.

Forget me Not café running at Holy Trinity in Chesterton, Newcastle, Staffs. They are running, Approach are supporting.

Swan Bank Church - dementia friends sessions held with members of the pastoral team, wardens, and the congregation with consideration for environment.

St Peter's - Hartshill Catholic Church - having dementia friends session to the Faith Worship Group - looking to develop this further.

St John's and Sacred Heart Church - Tamworth - dementia awareness sessions for parishioners.

Staffordshire Parish Council Association have signed up to the DAA; individual parish councils looking now to progress this further.

Post offices - Tamworth - Staffordshire - work in early stages started through writing to post offices, response being considered and if no response, visits to be made to each one. Also awaiting further guidance/information from the Alzheimer's Society national pilot underway.

## **HEALTH AND SOCIAL CARE**

GP practices - Staffordshire / North Staffordshire / Stoke - 16 surgeries have held Dementia Friends sessions. 14 surgeries have either already signed up to the DAA or are in the process of doing so.

North Staffordshire/Stoke CCG has signed up to the Dementia Action Alliance. Dementia Friends sessions held for staff and now mandatory as part of induction for new starters. (approximately 50-60 staff to date - more sessions planned).

Consistently above national diagnosis rates every month.

South Staffs CCGs applying for dementia friendly status.

Hospitals - staff can request bespoke training sessions to be delivered, established a Dementia Working Group, Butterfly Campaign, This is Me Campaign and John's Campaign established. Revised training programme to ensure Tier 1 training is being delivered. Receptorship Programme for new nurses and overseas nurses, reinvigorating dementia friends sessions to increase awareness, taken part in the national dementia audit, round 3, and formulated an action plan. Distributing parent and carer questionnaires and also looking at alternatives to questionnaires. Use of social media, research around crockery in conjunction with Staffordshire University. Encouraging opportunities for research.

Admiral Nurse post established, based at Douglas MacMillan Hospice, jointly funded by Douglas MacMillan and Dementia UK.

Dementia Steering Group held on a bi-monthly basis, well attended and guest speakers invited and welcomed on topics around dementia. Representatives sit on the group from health, social care and voluntary sector and individuals living with dementia, as well as carers.

Pharmacies - South Staffs commenced work with some local pharmacies. Some awareness work done with pharmacies in the north of the county (internal Medicine Management team at CCG) and some work with Head of Pharmacy for the area.

Work commenced with NHS England around dementia awareness programme for people living with dementia and supporting them and their carers to attend. To be included in dentist's registration application.

Stoke City Council - community wellbeing teams (social work staff) have had dementia awareness training.

Stoke / North Staffs - have developed a Dementia Passport and a pilot will begin shortly to evaluate whether people with a new diagnosis of dementia and their carers feel this document is a helpful tool in the ongoing management of their care and support.

Re-design of patient and carer pathways.

Work with NHS England to develop Dementia Friendly dentistry and dental practices.

## **FIRE AND POLICE**

Throughout Staffordshire, fire service investing in livery for Fire Engine appliances for a dementia campaign.

Sandyford Fire Station hosts a carers group every Thursday at the end of each month.

Staffs Fire and Rescue - consistently attend the Dementia Steering Group and input progress and updates.

## **HOUSING**

Dementia Friends sessions held at many different venues consisting of sheltered accommodation.

Stafford and Rural Housing - Dementia Friends sessions with staff and done sessions for residents in Mid-Staffordshire - Stone and Stafford.

Aspire Housing - Newcastle - Staffs - have some staff who are Dementia Friends Champions.

## **TRANSPORT**

Stoke-on-Trent - Staffordshire - Engaged with two taxi firms, one of whom has had a Dementia Friends sessions for staff, the other has had detailed information about dementia to share with drivers. Work is in early stages to develop and offer some additional voluntary training, incorporating dementia, to all of the local taxi companies.

Dementia Friendly Bus services - met with two companies who had a Dementia Friends session for a small group of staff, working with them to encourage training as part of continuous professional development for bus drivers.

Tamworth Borough Council - delivered Dementia Friends sessions for Arriva bus company and working with taxi drivers to do awareness training.
