- (iii) That an Air Quality Management Area be formally designated by Order under the provisions of Section 83(1) of the Environmental Act 1995 for an identified area of May Bank, Wolstanton and Porthill (Order number 4) as detailed.
- (iv) That an Air Quality Management Area be formally designated by Order under the provisions of Section 83(1) of the Environmental Act 1995 for an identified area of Little Madeley (Order number 3) as detailed.
- (v) That area specific Action Plans be developed to manage the Air Quality Management Areas within 12 months of the designation.
