Proposed Health and Wellbeing Centre which includes a 25m swimming pool, learner pool, spectator gallery, changing facilities, climbing wall, fitness suite, children's activity zone, dance studio and multipurpose room.

Holdcroft Motor Centre, Brunswick Street, Newcastle. Newcastle Borough Council. The Conservation Advisory Working Party felt that the design was not successful or locally distinctive with no contextual analysis and a poor design statement. The use of materials is over complicated with no dominant material. The design needs to be simpler and clearer for this important gateway into the town.
