10/208/FUL	Single storey side extension. Butterton Nurseries, Park Road, Butterton. Miss M Holton.	No objections subject to the design matching the existing bungalow.
10/223/FUL	Rear conservatory. The Rosary, Main Road, Betley. Mr S Goodall.	The Working Party objected to the poorly detailed drawings. The proposed conservatory was considered to be too large and out of scale with the modest cottage and also of an inappropriate design and use of materials. The plans did not match the elevations.
10/233/FUL & 10/234/LBC	Demolition of former kennel buildings and erection of detached dwelling with stable block and garage and change of use of land to garden.	The Working Party supported the application to repair and restore Clod Hall and considered the new proposal to be acceptable and would not harm the setting of Clod

10/248/FUL

Proposed first floor extension to rear and side above existing lounge and porch. 2 Pump Bank, Keele. Miss D Howe.

The Working Party welcomed the attention to detail of the extension in the estate style but wished to ensure the quality is carried through into the construction. Brickwork bonding and window and doors on the frontage should match the existing front elevation i.e. timber windows and English Garden wall bond.

10/260/FUL

Retention of boundary walls to plot numbers 3 and 4, erection of entrance gates and piers and associated landscaping. Butterton Nurseries, Park Road, Butterton. Butterton Nurseries Ltd. The Working Party could not come to a unified decision. Due to the existing development compromising this part of the Conservation Area, the Working Party had no objections. The Chair, having visited the site, and Vice Chair however felt that the walls were inappropriate and should be altered/modified due to their close proximity to the historic walled garden. Changes should be made to repeating pillars capstones and intrusive extraneous brick colours.

Detached double garage. The Estate House, Main Road, Betley. Mr D Dunkley. The Working Party welcomed the amended plans which are an improvement on the original proposal. No objections.
