# 75. \* HIGH STREET, WOLSTANTON APPLICATION FOR PREMISES LICENCE

#### Issues

Representations had been received from Staffordshire Police and interested parties living in the vicinity of the premises concerning the prevention of crime and disorder, the prevention of public nuisance and the protection of children from harm licensing objectives.

#### Resolved

The Sub-Committee having considered the relevant licensing objectives and having listened to the representations were persuaded that to grant a premises licence to the applicant would not offend the licensing objectives.

Therefore, subject to the mandatory conditions and also conditions consistent with those specified in the applicants operating schedule and set out below, the Sub-Committee were prepared to grant a licence for the premises:

## **Supply of Alcohol**

Monday to Sunday Inc 1500 to 2000 hours

### **Licence Conditions**

# i. The Prevention of Crime and Disorder

- a. To ensure that there is no sale of alcohol until the measures set out in the applicants operating schedule in addition to the mandatory conditions have been put in place by the applicant.
- b. To install CCTV giving internal coverage of the public areas (especially the area where alcohol is to be sold) as well as external coverage.

- c. To forge good communication links with the police and local authorities to ensure co-operation and to aid in the prevention of crime and disorder.
- d. To work closely with local crime prevention schemes will be implemented to help address disorder and violence.
- e. To ensure that alcohol is hidden from public view outside of licensing hours.
- f. To ensure that no notices are displayed relating to irresponsible drinks promotions on the premises.

## ii. Public Safety

- a. To utilise external lighting to cover all dark areas in order to facilitate CCTV coverage.
- b. To display signs that will help facilitate public safety (NHS helpline numbers etc.).
- c. To promote a sensible drinking message and avoid any actions that encourage drunkenness.

#### ii. The Prevention of Public Nuisance

- a. To ensure good relations with residents living within the vicinity of the premises and to address any noise reduction issues that may arise.
- b. To operate CCTV both internally and externally to assist with the prevention of public nuisance.
- c. To liaise immediately with the police should any problems relating to public nuisance arise.

#### iii. The Protection of Children from Harm

- a. There shall be no sale of alcohol to persons who appear to be under the age of 21 without the production of a proof of age card accredited under the Proof of Age Standards (PASS), a photo driving licence or a passport.
- b. Signs and notices shall be displayed indicating that the premises operate the 'Challenge 21' policy at the point of sale and at the front door of the premises.
- c. To utilise CCTV to ensure that the 'Challenge 21' policy is being correctly implemented.
- d. To avoid marketing that will appeal to young people.
