Issues

Representations had been received from Staffordshire Police concerning the prevention of crime and disorder, the prevention of public nuisance and the protection of children from harm licensing objectives.

Resolved

The Sub-Committee having considered the relevant licensing objectives and having listened to the representations agreed to grant the application.

Supply of Alcohol

Monday to Friday inc 0900 to 2230 hours Sunday 0900 to 2200 hours

Licence Conditions - 103 Congleton Road, The Village Store

In addition to the mandatory conditions, the following will apply:

i. <u>The Prevention of Crime and Disorder</u>

- a. There shall be no alcohol sales until the following conditions have been put in place by the applicant.
- b. CCTV shall be installed giving internal coverage of the public areas as well as external coverage.
- c. Provisions shall be put in place for the protection of staff.
- d. Signs and notices shall be displayed indicating that the premises operate the 'Challenge 21' policy and that there will be no sale of alcohol to persons under that age without the production of a proof of age card accredited under the Proof of Age Standards (PASS), a photo driving licence or a passport.

e. All cans, bottles and other containers of alcohol shall be indelibly marked with the premises logo.

ii. Public Safety

- a. All staff shall be trained regarding the 'Challenge 21' policy, health and safety and risk assessment.
- b. The layout of the premises shall be such that all risks to public safety are eliminated.
- c. CCTV shall be installed giving internal coverage of the public areas as well as external coverage.
- d. Signs shall be displayed to facilitate public safety.

iii. The Prevention of Public Nuisance

- a. To implement a dispersal policy regarding any group that may form outside of the premises.
- b. To implement measures will be taken to ensure that litter is not left in or around the premises.
- c. CCTV shall be installed to assist with the prevention of public nuisance.

iv. The Protection of Children from Harm

- a. There shall be no sale of alcohol to persons who appear to be under the age of 21 without the production of a proof of age card accredited under the Proof of Age Standards (PASS), a photo driving licence or a passport.
- b. Signs and notices will be displayed indicating that the premises operate the 'Challenge 21' policy.
- c. To utilise CCTV to ensure that the 'Challenge 21' policy is being correctly implemented.
