#### HS2 Phase 2

Submitted by: Executive Director, Regeneration and Development

Portfolio: Primarily Economic Regeneration, Business and Town Centres (High Speed Rail) and; Planning and Assets (Strategic Transport)

Ward(s) Affected: All

#### Purpose of the Report

To advise Cabinet of a letter sent by the Leader of the Council to the Leader of Stoke-on-Trent City Council concerning the City Council's response the Government's High Speed 2 Route Alignment (Phase 2).

#### **Recommendation**

- <u>a)</u> That the actions taken be noted.
- b) That the HS2 Working Party be asked to meet with representatives of the City Council to receive details of the City Council's proposals and to give full consideration to the possible implications of this alternative proposal for the Borough and to then report back to Council.

#### <u>Reasons</u>

To bring Cabinet up to date with the decision taken by the Leader of the Council, in consultation with the Leaders of both opposition parties, to submit a letter of in-principle support to the City Council, and to agree the next step.

#### 1. Introduction

- 1.1 At its Council meeting on the 30<sup>th</sup> January 2014 the City Council agreed to support the principle of promoting a Central HS2 Hub station in Stoke-on-Trent which would incorporate the upgrading of the West Coast Main Line (WMCL) from Stoke-on-Trent to Manchester.
- 1.2 At a meeting attended by Leaders and Chief Executives of all Staffordshire Local Authorities held on the 29<sup>th</sup> January 2014, the Leader of the City Council gave a briefing on the alternative proposal for the HS2 route which had been developed by his Council. At the conclusion of the presentation he asked that each Council present submit a letter of support in principle that could be included within the submission that was to be made by the City

Council by 5pm on the 31<sup>st</sup> January – the deadline for comments on the government consultation.

- 1.3 The Leader, having briefed the leaders of both opposition groups, submitted the letter attached at Appendix 1 to this report indicating that there are a number of details of the proposal which the Borough Council would wish to consider at greater length, however, on the basis that the proposal by the City Council would give significant economic benefit to North Staffordshire, the proposal is certainly something that the Borough Council would wish to support in principle.
- 1.4 This Council's Economic Development and Enterprise Overview and Scrutiny Committee established an HS2 Working Group that submitted its recommendations to a meeting of the Full Council on the 27<sup>th</sup> November 2013. As indicated in the attached letter it would be appropriate to ask the Working Group to reassemble and to meet with representatives of the City Council to consider in greater depth the possible implications of this alternative proposal for the Borough and to then report back to Council.
- 1.5 For completeness and in accordance with the Council resolutions made on 27<sup>th</sup> November 2013, members are advised that officers took the necessary steps, in consultation with the Chair of the Economic Development and Enterprise Overview and Scrutiny Committee, to submit a joint representation to Government as set out in the document referred to at Appendix 2.

#### 2. Legal and Statutory implications

2.1 There are none at this stage – HS2 Phase 2 being not yet at the Hybrid Bill Stage.

I welcomed the opportunity to receive your briefing on the alternative proposal for the HS2 route which has been developed by the City Council. You will appreciate there are a number of details of your proposal which we would wish to consider at greater length. However, on the basis that the proposal by the City Council would give significant economic benefit to North Staffordshire, this is certainly something which this council would wish to support in principle.

We have seen the econometric analysis produced by KPMG which shows that the impact of there not being a station stop in Stoke and Staffordshire North has a negative impact on our economy of upto £78m per annum. The work undertaken on your proposal suggests an estimated uplift in Gross Additional GVA of 52% and therefore will considerably assist the regeneration of this area.

You will be aware of the work of the Member Working Group which has developed this council's response to the consultation process. Indeed, we were grateful to the input made by the City Council to this process. At the time we met you proposed alternative route alignment had not been formulated and it may be appropriate that we reconvene that Group to consider in more detail your proposal.
