The Committee considered a report regarding the revocation of a Hackney Carriage driver's licence held by Mr KH.

Resolved: That the Chief Executive's decision to revoke Mr KH's licence with immediate effect be endorsed.

The Committee considered a report regarding the revocation of a dual driver's licence held by Mr CRJ.
