32. LOCAL GOVERNMENT (MISCELLANEOUS PROVISIONS) ACT - 1976 - APPLICANT 1

The-Sub Committee considered a renewal application for a Dual Hackney Carriage and Private Hire Driver's licence. The application was before the Sub-Committee as the application process revealed a conviction that fell within the requirements of the Council's Licensing Policy. After very careful consideration of information from the Council's Licensing Officer and representations from the applicant, the Sub-Committee agreed as follows:

- (b) The Driver be issued with a warning as to future conduct due to inaccuracies in the application process.

33. LOCAL GOVERNMENT (MISCELLANEOUS PROVISIONS) ACT - 1976 - APPLICANT 2

34. LOCAL GOVERNMENT (MISCELLANEOUS PROVISIONS) ACT - 1976 - APPLICANT 3

The Sub-Committee considered a new application for a Hackney Carriage Vehicle Licence. The matter was before the Sub-Committee as the application fell outside of the Council's Licensing Policy.

The matter had been deferred from a previous meeting due to the non-attendance of the applicant but the applicant was also not in attendance at this meeting. Resolved: that the application for a Hackney Carriage Vehicle Licence be refused on the grounds that the vehicle does not comply with the Council's Taxi Licensing Policy and the Sub-Committee has not heard anything to allow it to depart from policy on this occasion.
