The group felt that the proposal was unsustainable in terms of its embodied energy but respected the careful consideration which had been given to the design process.

There was some concern over the tunnel effect which would be created by its massing in conjunction with the proposal for flats on Liverpool Road and that this would not be betterment for this gateway site into the town centre conservation area.

Conservation Advisory Working Party - 18/04/23

All felt that the material for the towers was inappropriate and should be a sandstone cladding. Also that the metal fins were an alien material and that wood was preferable and that they created a rather busy appearance and the rhythm would be improved with larger units.

There was concern that the tower closest to the subway would be rarely used and presented a potential risk for anti-social behaviour. On a practical level there was a question that the ventilation was adequate.

A 3D view with some context would be useful. The elevational treatment doesn't work with the mass of the building and the group objected to the proposed materials. The landscaping is poor. A contemporary solution possible with understanding and the group remains unconvinced that the site fully considered with regard to energy saving possibilities. 


