### **GUIDANCE NOTES**

### **NATURAL JUSTICE AND FAIRNESS**

These are the principles used in the determination of just or fair processes and stem form the common law legal system.

According to Roman law, certain basic legal principles were so obvious that they should be applied universally without the need to be enacted into the law.

The rules of natural justice are now regularly applied by courts in both common law and civil law jurisdictions.

Natural justice operates on the principles that man is basically good, that a person of good intent should not be harmed and one should treat others as they would like to be treated

Natural justice includes the notion of procedural fairness and may incorporate the following guidelines:-

- A person accused of a crime, or at risk of some form of loss, should be given adequate notice about the proceedings (including any charges);
- A person making a decision should declare any personal interest they may have in the proceedings;
- A person who makes a decision should be unbiased and act in good faith. He
  therefore cannot be one of the parties in the case, or have an interest in the
  outcome. This is expressed in the Latin maxim, nemo iudex in causa sua: "no
  man in permitted to be judge in his own cause";
- Proceedings should be conducted so they are fair to all the parties expressed in the Latin maxim, *audi alteram*: "let the other side be heard";
- Each party to a proceeding is entitled to ask questions and contradict the evidence of the opposing party;
- A decision-maker should take into account relevant considerations and extenuating circumstances, and ignore irrelevant considerations;
- Justice should be seen to be done. If the community is satisfied that justice has been done they will continue to place their faith in the courts.

Where a person's legal rights are concerned, the principles of natural justice are bolstered by Article 6 of the European Convention on Human Rights which is now incorporated into domestic law.

### THE RULE AGAINST BIAS

It is elementary to the rules of natural justice that the deciding body is to be free from bias.

The rule is that the body must be <u>and be seen to be</u> impartial, independent and disinterested.

There are two broad categories of bias:

- (a) <u>Actual Bias</u>: when the decision-maker has an economic interest in the outcome of the case (also known as a material or pecuniary interest) subject to the De Minimum doctrine;
- (b) Reasonable Apprehension: unbiased appearance is an essential part of procedural fairness. The test is whether, having regard to the circumstances, a well informed person ("reasonably informed bystander") would consider that the interest might have an influence on the exercise of the decision-maker's duties.

### **GUIDANCE NOTES**

### **HUMAN RIGHTS ACT 1998**

In considering allegations against Members you should have regard to the provisions of the Human Rights Act 1998 which embody the rules of natural justice.

### Rights and Freedoms to be considered when determining matters

### ARTICLE 6: RIGHT TO A FAIR TRIAL

- 1. In the determination of his civil rights and obligations or of any criminal charge against him, everyone is entitled to a fair and public hearing within a reasonable time by an independent and impartial tribunal established by law. Judgement shall be pronounced publicly, but the press and public may be excluded from all or part of the trial in the interest of morals, public order or national security in a democratic society, where the interests of juveniles or the protection of the private life of the parties so require, or to the extent strictly necessary in the opinion of the court in special circumstances where publicity would prejudice the interests of justice.
- 2. Everyone charged with a criminal offence shall be presumed innocent until proved guilty according to law.
- 3. Everyone charged with a criminal offence has the following minimum rights:
  - (a) to be informed promptly, in a language which he understands and in detail, of the nature and cause of the accusation against him;
  - (b) to have adequate time and facilities for the preparation of his defence;
  - (c) to defend himself in person or through legal assistance of his own choosing or, if he has not sufficient means, to pay for legal assistance, to be given it free when the interests of justice so require:
  - (d) to examine or have examined witnesses against him and to obtain the attendance and examination of witnesses on his behalf under the same conditions as witnesses against him;
  - (e) to have the free assistance of an interpreter if he cannot understand or speak the language used in court.

### ARTICLE 8: RIGHT TO RESPECT FOR PRIVATE AND FAMILY LIFE

- 1. Everyone has the right to respect for his private and family life, his home and his correspondence.
- 2. There shall be no interference by a public authority with the exercise of this right except such as is in accordance with the law and is necessary in a democratic society in the interests of national security, public safety or the economic well being of the country, for the prevention of disorder or crime, for the protection of health or morals, or for the protection of the rights and freedoms of others.

### ARTICLE 10: FREEDOM OF EXPRESSION

 Everyone has the right to freedom of expression. These rights shall include freedom to hold opinions and to receive and impart information and ideas without interference by public authority and regardless of frontiers. This Article shall not prevent States from requiring the licensing of broadcasting, television or cinema enterprises. 2. The exercise of these freedoms, since it carries with it duties and responsibilities, may be subject to such formalities, conditions, restrictions or penalties as are prescribed by law and are necessary in a democratic society, in the interests of national security, territorial integrity or public safety, for the prevention of disorder or crime, for the protection of health or morals, for the protection of the reputation or rights of others, for preventing the disclosure of information received in confidence, or for maintaining the authority and impartiality of the judiciary.

### ARTICLE 14: PROHIBITION OF DISCRIMINATION

The enjoyment of the rights and freedoms set fourth in this Convention shall be secured without discrimination on any ground such as sex, race, colour, language, religion, political or other opinion, national or social origin, association with a national minority, property, birth or other status.

NB This is not a substantive right, but comes into play if other rights are likely to have been infringed. The prohibition is wide, but not exhaustive

### ARTICLE 1: OF THE FIRST PROTOCOL PROTECTION OF PROPERTY

Every natural or legal person is entitled to the peaceful enjoyment of his possessions. No one shall be deprived of his possessions except in the public interest and subject to the conditions provided for by law and by the general principles of international law.

The preceding provisions shall not, however, in any way impair the right of a State to enforce such laws as it deems necessary to control the use of property in accordance with the general interest or to secure the payment of taxes or other contributions or penalties.

NB Possessions, in this context, includes the right to apply for a licence, the right to hold and retain a licence and the goodwill of a business.

NOTE In this context it is also particularly important for members to observe the rule against bias.

## PROCEDURE TO BE FOLLOWED BY THE LICENSING SUB-COMMITTEE

### NOTE:

All hearings will normally be held in public. However, the Licensing Sub-Committee may exclude the public from all or part of a hearing where it considers that the public interest in so doing outweighs the public interest in the hearing or that part of the hearing taking place in public. A party or that party's representatives may be treated as a member of the public and therefore excluded from the meeting for all or part of the hearing, and all parties have the right to be represented and to call witnesses.

The Clerk to the Committee will have the right to ask questions on behalf of the Committee of any party to the proceedings.

### **PROCEDURE**:

- 1. The Chair of the Sub-Committee will open the meeting and introduce the members of the committee and call upon the parties to identify themselves and their representatives and to identify any witnesses they intend to call.
- 2. The Chair of the Sub-Committee will call upon the Clerk to the Committee to explain to the parties the procedures which will be followed at the hearing. Unless the Chair directs otherwise, each party will normally have a maximum period of one hour in which to give further information and call any witnesses in support of their case. In every case, all parties will have an equal maximum period.
- 3. The Chair of the Sub-Committee will then normally call upon the interested party or the responsible authority which has made a relevant representation against the grant of an application to provide evidence in support of their representation.
- 4. The applicant will then have an opportunity to question that person
- 5. Members of the Sub-Committee will then have the opportunity to question that party or responsible authority.
- 6. Any person who has made relevant representations will then call any witness in support.
- 7. The applicant will then have an opportunity to question that witness.
- 8. Members of the Sub-Committee will then have the opportunity to question that person.
- 9. Stages 6 to 8 will then be repeated for each person making relevant representations.
- 10. The applicant will then have the opportunity to give evidence in response to the application and in response to the relevant representations which have been made.
- 11. The interested party or responsible authority will then have an opportunity to question the applicant.

- 12. Members of the Sub-Committee will then have the opportunity to question the applicant.
- 13. Stages 10 to 12 will be repeated for any witnesses on behalf of the holder of the applicant.
- 14. The interested party or responsible authority will have the right to address the sub committee.
- 15. The applicant will have the right to address the Sub-Committee in summing up his case.
- 16. All parties will then leave the room while the Sub-Committee consider their decision.
- 17. The Sub-Committee will normally make their determination at the conclusion of the hearing, but when this is not possible, will make its determination within the period of five working days beginning with the day on which the hearing was held.

### **Purpose of the Report**

To inform the Sub-Committee of an application to vary a premises licence which has received a relevant representation.

### **Recommendation**

That Sub-Committee:

In accordance with the Licensing Act 2003, the statutory guidance and the Council's own Statement of Licensing Policy the Sub-Committee must consider the Premises Licence variation application and have regard to the four licensing objectives, as below, when making its decision:

- (i) The Prevention of Crime and Disorder
- (ii) Public Safety
- (iii) The Prevention of Public Nuisance
- (iv) The Protection of Children from Harm

### **Reasons**

On 11 March 2025 an application to vary the premises licence was received from Newcastle Pizza Limited for Caprinos on Liverpool Road. As part of the consultation that ended on 09 April 2025, a representation was received in objection to the application.

### 1. Background

1.1 The licence information relating to this application is as follows:

Premises: Caprinos

Location: 131 Liverpool Road, Newcastle Under Lyme, ST5 9HD

Licence Number: 18076

Premises Licence Holder: Newcastle Pizza Ltd (Company number 15337442)

1.2 This matter was initially considered on the 4 June 2025 by the Licensing Sub-Committee however due to delays caused by a failure to reach an agreement between the applicant and the responsible authority of environmental health the session started late and the sub-

committee members felt that they did not have enough time to consider the matter in a fair and proportionate manner due to time constraints and so the matter was adjourned. The decision letter is attached as **Appendix A** which details the sub-committee's decision to adjourn the matter and also their recommendation that a noise assessment, the findings in regard to the ventilation system and concise and enforceable conditions be included within the report for the new hearing.

- 1.3 In light of this decision, **Appendix B** includes a noise impact assessment provided to the Council by the applicant's representative on the 24 June 2025 and **Appendix C** includes the ventilation specification for the installation at the premises which were provided to the environmental health officer on the day of the previous hearing.
- 1.4 Prior to the June hearing a statement, attached as **Appendix D**, was provided by the applicant in relation to their application. In response to this an officer has formalised the conditions proposed in the statement, and these are attached as **Appendix E**.
- 1.5 Caprinos has held a premises licence to authorise late night refreshment since 06 July 2018. The hours authorised by the premises licence were Sundays to Thursdays 23:00 until 00:00 and Fridays and Saturdays 23:00 until 01:30. A copy of the current premises licence can be found at **Appendix F.**
- 1.6 On 11 March 2025, a variation application was received to extend the opening hours and the hours for late night refreshment until 03:00 hours on Sundays to Thursdays and until 04:00 hours on Fridays and Saturdays. A copy of this application form and supporting evidence submitted by the applicant following the representation is attached at **Appendix G.**
- 1.7 On 13 March 2025, a relevant representation from the Environmental Protection Team was received in objection to the application. The objection was made regarding the prevention of public nuisance and highlighted that the premises is in a residential area with the nearest residential bedroom being approximately 36 metres away. The objection raises concerns about the late-night noise that might be generated by patrons and delivery drivers and that there is no other late night commercial use in the vicinity until 04:00 hours. A copy of this objection, including additional correspondence between Licensing and Environmental Health, is attached at **Appendix H.**
- 1.8 On 1 April 2025, email correspondence was received from the Planning Department stating that the premises does not have any consent for the advertising signage at the premises or the outbuilding at the rear of the premises. On 7 April 2025 a further email was received from the Planning Department confirming that they will not be making an objection against this application and on 8<sup>th</sup> April the Planning Enforcement Officer confirmed that he was confident that the applicant would apply for retrospective planning for the matters outlined in his email of 1 April. A copy of the emails from planning can be found at **Appendix I.**
- 1.9 On 17 January 2025 the Licensing Team received notification that Mr SALEEM had registered as the new Food Business Operator (FBO) of the Caprinos and so the licensing team wrote to Mr SALEEM on 20<sup>th</sup> January requesting an application to transfer the premises licence. This email clearly details the hours authorised by the current premises licence. A copy of this correspondence can be found at **Appendix J.**
- 1.10 On 5 February and 19 February 2025, a Licensing Officer chased the outstanding transfer application, and it was at this point, that it was noticed that the premises was advertising hot food for supply as late as 04:00 hours which is 2 hours and 30 minutes later than their premises licence authorises. In response to this a Licensing Officer telephoned the premises and left a message with a shop worker to say that they must not trade in excess of



what their premises licence authorises. A copy of the action log can be found at **Appendix K.** 

- 1.11 Later the same day on 19 February 2025 the Licensing Team received a call from the new owner of the premises Mr Saleem, asking if he could stay open until 03:00-04:00 hours until he has had time to complete the transfer and variation applications. Mr Saleem claimed that the business was partnered with Uber Eats, Deliveroo and Just Eat and if he was to close early and not fulfil the orders then it would be bad for business and incur a financial penalty. A copy of the notes taken during the telephone conversation can be found at **Appendix K**. This was later supported by a written request to trade outside of his hours, a copy of the email can be found at **Appendix L**.
- 1.12 On 19 February and 24 February 2025 warning letters were sent to the premises licence holder at the time, being Mr Rafique and also to the new business owner Mr Saleem. The warning letters set out the offence of carrying out licensable activity without authorisation. A copy of the letter and email correspondence can be found at **Appendix M**.
- 1.13 On 24 February 2025 Mr Saleem emailed the Licensing Team to confirm that the trading hours of the premises were corrected as of the 19 February 2025 and that he would apply to transfer the premises licence into his business name. A copy of this email is attached at **Appendix L.**
- 1.14 On 27 February 2025 Newcastle Pizza Ltd (Company number 15337442) applied to transfer the premises licence.
- 1.15 On 24 April 2025 a check of Companies House confirms that Mr Muhammad Husham SALEEM is the Sole Director of Newcastle Pizza Limited. A copy of the Companies House record can be found at **Appendix N.**
- 1.16 Google street view images of the premises location is attached at **Appendix O**, and a GIS location plan of the premises is attached at **Appendix P**.
- 1.17 The premises is located within the area covered by the Council's recently updated Cumulative Impact Assessment which is attached as **Appendix Q**.

### 2. **Issues**

- 2.1. The Licensing Act 2003 requires the Council to carry out its various licensing functions so as to promote the following four licensing objectives;
  - (i.) The Prevention of Crime and Disorder
  - (ii.) Public Safety
  - (iii.) The Prevention of Public Nuisance
  - (iv.) The Protection of Children from Harm
- 2.2. The Licensing Act 2003 requires the Council to publish a "Statement of Licensing Policy" that set out the policies the Council will generally apply to promote the licensing objectives when making decisions on applications made under the Act. Copies of the Council's Statement of Licensing Policy and the Government's Statutory Guidance will be available at the Licensing Sub-Committee hearing.
- 2.3. In making their decision on the application, the Sub-Committee are obliged to have regard to the Statutory Guidance, the Council's own Statement of Licensing Policy and the Council's Cumulative Impact Assessment. The Sub-Committee must also have regard to the

representations made and the evidence heard at the hearing. However, the Sub-Committee must disregard any representations that do not relate to the promotion of the four licensing objectives.

### 3. **Recommendation**

- 3.1 The Sub-Committee, where it considers that action under its statutory powers is appropriate, may take any of the following steps for the promotion of the four licensing objectives. The steps available to the Sub-Committee are listed in Section 5.1 of this report.
- 3.2 The applicant has offered a compromise by way of a 1 hour reduction from the hours originally applied for. The details of this can be found on **page 16 of Appendix G.** The applicant has also suggested a number of ways in which they would aim to control any noise nuisance from the premises, including operating a delivery only service after midnight on Sundays to Thursdays and after 01.30 hours on Fridays and Saturdays, and using audio recording on the CCTV system (**page 15 Appendix G**) which could be added as licence conditions.
- 3.3 The conditions of the licence are modified if any of them are altered or omitted or any new condition is added.
- 3.4 The Sub-Committee are asked to note that they may not modify the conditions or take any other steps merely because they consider it desirable to do so. Any action taken must be appropriate in order to promote the licensing objectives.

### 4. Reasons

4.1 To ensure that the Council promote the licensing objectives in accordance with their statutory duty.

### 5. Options Considered

- 5.1 The relevant options considered in relation to this application are:
  - (a) to grant the application as applied for:
  - (b) to grant the application with modified conditions and/or timings;
  - (c) to refuse the grant of this variation application.

### 6. **Legal and Statutory Implications**

- The power to determine an application to vary a premises licence which falls under Section 35 of the Licensing Act 2003.
- 6.2 Hearings will be carried out in a fair, proportionate, and consistent manner in line with:

Article 6(1) guarantees an applicant a fair hearing. Article 14 guarantees no discrimination.

Licensing Act 2003 Sub-Committee – 4 June 2025 Application to vary a Premises Licence Caprinos, 131 Liverpool Road, Newcastle-under-Lyme, Staffordshire, ST5 9HD

I am writing to notify you of the decision taken by the Licensing Sub-Committee on 4 June 2025. The Licensing Sub-Committee proposed to adjourn the hearing of the application to vary the licence on the grounds outlined below.

### Summary:

In respect of the variation application made by Newcastle Pizza Ltd T/A Caprinos Pizza on the 11 March 2025 under the Licensing Act 2003 to extend the licensable hours to provide late night refreshment at 23:00-03:00 hours on Sundays to Thursdays and 23:00-04:00 hours on Fridays and Saturdays. During the consultation period of the application, a representation was received from the Environmental Protection Team in relation to the prevention of public nuisance. This representation was deemed relevant.

At the time that the meeting was due to commence discussions were ongoing between the applicant and the representative from Environmental Protection, Mr Robert Thomas in relation to proposed conditions and alterations to the application in relation to the terminal hours being reduced by one hour each day. As there was still some disagreement between both parties, an officer from the licensing team proposed that the applicant request for the meeting to be adjourned to take all matters into account.

Discussions continued, without resolution, for a significant time between both parties, at which point the three members of the sub-committee required all parties to come into the meeting room so that they could discuss the case.

The Chairman of the Sub-Committee Councillor John Williams opened the hearing at approximately 3:40pm.

### Decision:

In making their decision the licensing sub-committee carefully considered the application, the report, the Licensing Act 2003, the statutory guidance and the Council's own Statement of Licensing Policy.

Due to the time that had passed, without the members having full knowledge of the discussions between the applicant, his representative and the Environmental Health Officer, it was felt that a fair and considered decision could not be reached at this meeting. The members proposed that the matter was adjourned to a later date and that a noise assessment, the findings in regard to the ventilation system and concise and enforceable conditions be included within the report prior to the new meeting being held. The members also requested that, if possible, the same three councillors attend on the new date due to their familiarity with the matter.

### 1.0 INTRODUCTION

SBM Safety Solutions Ltd attended Caprinos pizza take-away located at 131 Liverpool Road, Newcastle Under Lyme, ST5 9HD on the instructions of the proprietor to carry out sound measurements which would inform this noise impact assessment.

This assessment would evaluate the potential for adverse impact from an existing kitchen extraction system. The plant will operate when the take-away is open and the proprietors are seeking to extend opening hours to 3:00am. The extraction hood and ducting are located within the ground floor restaurant and culminates at the rear of the building where the outlet is situated. It is at the rear where there is the potential for adverse impact on nearby residents.

Measurements were taken on the 12<sup>th</sup> of June 2025 at two position – close to the ducting at approximately 6m and at the driveway of one of the nearest houses at approximately 20m from the ducting. The nearest residential location is approximately 30m from the noise source. As the sounds will be present after 11pm it is likely that the houses and not the gardens where the residents could potentially be affected, i.e. at 30m from the source. This report discusses the results of that monitoring and assesses the potential for adverse impact.

### 2.0 SITE DESCRIPTION

The take-away is situated close to the town of Newcastle-under-Lyme, a market town in the north of Staffordshire. There are existing similar businesses on each side of the take-away – immediately on the right and adjoining there is "Spice Grill", at approximately 40m to the south there is a Pizza Hut outlet with car park and at approximately 140m a Kentucky Fried Chicken outlet.

There is also extraction plant at the rear of Spice Grill – this was not operating during the survey.

The nearest residential area to the site is located to the west and south at approximately 30m to the west of Caprinos.

The take-away wishes to extend opening until 3:00am

### 3.0 NOISE CRITERION

# 3.1 BS4142:2014 – Rating Industrial Noise Affecting Mixed Residential and Industrial Areas

BS4142:2014 states, "Response to sound can be subjective and is affected by many factors, both acoustic and non-acoustic.

The significance of its impact, for example, can depend on such factors as the margin by which a sound exceeds the background sound level, its absolute level, time of day and change in the acoustic environment, as well as local attitudes to the source of the sound and the character of the neighbourhood...This British Standard describes methods for rating and assessing sound of an industrial and/or commercial nature".

This British Standard describes a method for assessing whether a specific sound may have an adverse impact. The Standard requires that the ambient noise (totally encompassing sound in a given situation at a given time, usually composed of sound from many sources near and far) including the "specific" sound from the source in question is measured in terms of the equivalent continuous sound level LAeq [see Appendix 1 for acoustic terms], which is then corrected for the residual sound (total LAeq excluding the "specific" sound).

A correction for character is made if "a tone, impulse or other characteristic occurs". For tonality, a correction of between +2dB and 6dB is considered acceptable and for impulsivity between 3 and 9dB. See table below.

Where the specific sound features characteristics that are neither tonal nor impulsive, though otherwise are readily distinctive against the residual acoustic environment, a penalty of 3 dB can be applied. Where tonal and impulsive characteristics are present in the specific sound within the same reference period then these two corrections can both be taken into account. If one feature is dominant, then it might be appropriate to apply a single correction. Where both features are likely to affect perception and response, the corrections ought normally to be added in a linear fashion.

### Intermittency

"When the specific sound has identifiable on/off conditions...if the intermittency is readily distinctive against the residual acoustic environment, a penalty of 3 dB can be applied".

The final figure, including any character correction is known as the Rating level. This Rating Level is then compared with the measured background [LA90] level. The greater this difference the greater the likelihood of "adverse impact" (See Notes 1 & 2 from BS4142:2014 below).

### NOTE 1

- a) Typically, the greater this difference, the greater the magnitude of the impact.
- b) A difference of around +10 dB or more is likely to be an indication of a significant adverse impact, depending on the context.
- c) A difference of around +5 dB is likely to be an indication of an adverse impact, depending on the context.
- d) The lower the rating level is relative to the measured background sound level, the less likely it is that the specific sound source will have an adverse impact or a significant adverse impact. Where the rating level does not exceed the background sound level, this is an indication of the specific sound source having a low impact, depending on the context.

#### NOTE 2

Adverse impacts include, but are not limited to, annoyance and sleep disturbance. Not all adverse impacts will lead to complaints and not every complaint is proof of an adverse impact.



### 4.0 MEASUREMENT PROCEDURE

The site was visited in the early hours of Thursday 12<sup>th</sup> June 2025 and instrumentation was installed at 20m from the plant close to the garden of one of the nearest houses (with a clear view of the plant) and also close to the plant at 6m. The equipment at 6m was used to establish plant noise only – any extraneous sounds paused out etc., and at 20m where the equipment was left running for the monitoring period for 15-minute intervals which is the reference time period for nighttime from BS4142.

The weather conditions during the survey period were dry, warm and with little wind. There were temperatures of 15 to 17 degrees Celsius and a wind speed 0.5-2.3m/s (SE) measured on an electronic anemometer, although slightly stronger winds were forecast.

It is not considered that weather conditions would have influenced the results.

The sound level meters used, and ancillary equipment can be found in the table below. The meters calibrated correctly before and after the on-site measurements at 94dBA (977A) and 94dBA (977C) to within +/- 0.2dBA.

The instrumentation has been laboratory calibrated within the preceding 2 years.

### 6.0 ADDITIONAL OBSERVATIONS

As noted above, there were very occasional vehicles passing on Liverpool Road.

It can be seen in the table above the typical background level (with plant off) is **38dBA**.

The plant was **not audible** to the observer at 20m.

### 7.0 ASSESSMENT OF RESULTS

### 7.1 BS4142

Levels from the plant in close proximity.

Our measured levels of the plant at **6m** were **50-51dBA** using the L90 indices to eliminate any additional extraneous sounds (others were paused out).

The LAeq, 15-minute levels at 20m are very similar with the plant operating and not – in fact a little lower when the plant was operating which suggests that there is very little influence from the plant on the ambient noise levels. The same applies to the L90 levels too.

We can also look at the plant level at **6m** to estimate the resultant noise level at the nearest houses (30m) – a correction for distance needs to be applied (point source):

20LOG (distance of measured level / distance to residential property) 20LOG (6 / 30) = -14dBA

51 - 14 = 37dBA (to nearest whole decibel).

The observer could not discern any sounds or characteristics of plant noise at 20m, e.g. a "hum" and so a correction has not been applied to the BS4142 assessment below.

Conclusion – "Where the rating level does not exceed the background sound level, this is an indication of the specific sound source having a low impact, depending on the context."

### 7.2 Uncertainty

The following factors have a bearing on the uncertainty of the assessment:

- The existing ambient / background level was established during one monitoring period, but this was in the early hours of the morning after midnight on a weekday and so can be considered worst case. Other sources (occasional passing cars) were paused out of the plant noise measurements at 6m.
- Ambient and background noise levels may be higher during weekend periods which will reduce the likelihood of adverse impact still further.

Overall, it is considered that the assessment is sufficiently robust.

### 8.0 DISCUSSION AND CONCLUSIONS

The extension of opening hours will of course also have economic benefits with the creation of additional jobs as well as well as providing a useful flexible service for customers in an increasingly 24-hour economy.

### 9.1 BS4142

Given the existing noise climate and context of this location there is likely to be "**low impact**" – the context in this case being that the building has operated as a take-away previously and there are many similar establishments in the area.

This is especially so given the increase in the number of deliveries only orders (reducing actual footfall). A noise management plan is also suggested below.

Also, the nearby residents may be less sensitive than at other locations where there has been no previous similar use.

### 9.2 LOAEL / SOAEL

It is likely that the noise will "No Observed Effect" or there will be "No Observed Adverse Effect (NOEL)"

Given the existing and historical uses:

"Sounds will not be noticeable...may be noticeable and not intrusive. Noise can be heard but does not cause any change in behaviour or attitude. Can slightly affect the acoustic character of the area but not such that there is a perceived change in the quality of life."

### 9.3 Overall

With good site management there should be no reason why the site should not be permitted to extend opening hours based on the assessment and discussion above.

### 9.4 Noise Managements – Suggested Plan

### **Kitchen sounds, Patrons and Delivery Vehicles**

Keep doors and windows closed to prevent kitchen and takeaway reception sounds breaking out of the building.

Patrons arriving on site are unlikely to be an issue especially with the plan for increasing deliveries. Delivery vehicles sounds are likely to be similar to other vehicles on Liverpool Road. Later in the day and in the early hours the associated sounds with delivery vehicle noise can be managed by staff – e.g. designated parking (front) and training as noted below.

### **Noise Breakout**

The following additional noise control measures are recommended:

- Keep doors and windows closed.
- Avoid using the rear yard after 11:00pm.

### **Training**

Management should ensure appropriate staff training covering:

- Awareness of responsibilities for noise, e.g., responding to complaints.
- Delivery drivers
  - Parking away from any residential properties.

- Keeping doors closed.
- No revving of engines.
- Keeping car radios and sound systems turned down.
- No slamming of doors.
- Keeping to a slow speed e.g., 5-10mph.
- Keeping routes to the delivery doors free from obstacles.
- Minimising the amount of time for collection.
- No gathering outside of the premises remaining in the vehicle until summoned for collection.

### **Doors and Windows**

Doors should not be opened unnecessarily, and windows should be kept closed. Also, keep the doors and windows of adjacent rooms, such as toilets and corridors, closed especially if they are next to noise sensitive residential properties.

### Ventilation

Ventilate the premises by artificial means, if possible, to avoid opening doors and windows (see noise limits for external plant as noted above for the extraction system).

### **Entrance and Outside Areas**

This noise source is usually from raised voices and is likely to be especially noticeable at night. Post notices close to exit doors requesting that customers leave quickly and quietly.

### **Deliveries / Collections (Stock)**

Restrict driver collections at night to the front of the takeaway and delivery times as far as possible to those where disturbance would be minimised. Limit the number and/or frequency of such activities.

### **Monitoring**

The front and rear should be visited periodically by management to check on noise levels emanating from the premises and patrons.

### **APPENDIX 1**

### **EXPLANATION OF ACOUSTIC TERMS**

The dB or the decibel, is the unit of noise. The number of decibels or the level, is measured using a sound level meter. It is common for the sound level meter to filter or 'weight' the incoming sound so as to mimic the frequency response of the human ear. Such measurements are designated **dB(A)**.

**A doubling** of the sound is perceived, by most people, when the level has increased by 10 dB(A). The least discernible difference is 2 dB(A). Thus, most people cannot distinguish between, say 30 and 31 dB(A).

**The Background level** of noise is most commonly represented by the level which is exceeded for 90% of the time i.e. the LA90.

If a noise varies over time, then the **equivalent continuous level, or LAeq**, is the notional constant level of noise which would contain the same amount of acoustic energy as the time varying noise.

The following table gives an indication of the comparative loudness of various noises expressed in terms of the A weighted scale:

# SUPPORTING STATEMENT- 03/06/25

Subject- Grant of Premises License for Caprinos Pizza Newcastle-under-Lyme, 131 Liverpool Road, ST5 9HD

Further to the response received from Environmental Health (dated 2<sup>nd</sup> June 2025) in relation to our premises license we would like to provide some further evidence to support our request for the extension of operational hours as submitted.

We note that the EH team refer to the hot food takeaway SPG (1996) however this is the same document that would have been taken into account when determining other nearby late night refreshment licenses that have been granted for later hours and also our own current license which we hold.

The EH team have not commented any further on the below examples (noted in Appendix) which we have provided in relation to their distances to the nearby residential premises and we feel that our business is being singled out a little as a result of this. We understand that the noise element seems to be the main 'public nuisance' however to date we have not had any noise related complaints during operational hours and also any request for a formal acoustic impact assessment to be carried out. It is therefore our assumption with the lack of further evidence provided by EH that none of the other approved late night licenses of similar hours that we propose did in fact provide such acoustic reports at the time.

The EH team have also not provided any further actual noise related data/readings from the area to confirm the Caprinos Pizza would in fact be making a detrimental impact on the local residents as a result of the extended hours being proposed.



In order to promote the licensing objectives we are happy to install noise monitoring equipment and keep a log of the noise levels after standard business hours so these can determine whether the premises does generate a lot of noise and cause nuisance. Details provided in the appendix of the Minut system which many businesses use to assist with live noise monitoring. We feel this is a reasonable approach as are unable to provide a full noise impact assessment considering the response from EH requesting this was received on 03/06/25.

As a summary we have also provided some further clarification to the points EH have raised in their recent response.

## 1. Noise from Delivery Vehicles and Drivers

Our delivery operation is modest, involving a maximum of 2 drivers at night, occasionally rising maximum up to 3 in brief peak periods.

Drivers use small, fuel-efficient vehicles, including a hybrid electric vehicle, which produces near-silent engine noise.

All drivers receive formal training to reduce noise disruption. They are instructed:

Never to use horns

Not to play music or radios while arriving or waiting

To be respectful and quiet in and around the premises

Drivers enter and exit exclusively via the A34 and are prohibited from using Wilton Street after 12:00 AM (midnight). We are happy for this to be a formal condition of the licence.

#### 2. Customer Collections After 1:00 AM

We are fully willing to accept a licence condition preventing customer collection after 1:00 AM.

After this time, Caprinos will operate as a delivery-only service, eliminating late-night footfall and reducing external noise.



#### 3. Ventilation Fan and Kitchen Noise

The kitchen operates a single-motor ventilation system and does not use any fryers or high-noise appliances.

The main oven in use is an XLT conveyor oven, widely recognised for its low-noise operation.

The only other machinery is a quiet make line, and only one staff member works during late hours, significantly reducing activity.

If required, we are willing to install a silencer on the fan, and/or introduce noise monitoring equipment to demonstrate compliance with acceptable levels.

Importantly, when the current licence was granted to the previous owner for 131 Liverpool Road, no concerns were raised about the fan or noise emissions, either by the council or through public representation. We would respectfully ask why these concerns are now being raised when there have been no material changes to the premises or equipment.

#### 4. Noise Through Party Wall

Late-night operations are minimal, with no loud equipment, no heavy foot traffic, and only one staff member present.

Nevertheless, we are willing to commission an acoustic assessment of the party wall and implement any reasonable soundproofing or mitigation measures recommended but to our understanding the walls would have been acoustically lined during the refurbishment process as no complaints have been raised to date in relation to noise transfer between properties.

# 5. Use of Wilton Street

There is adequate parking at the front of the premises, and drivers have no need to use Wilton Street. To further address concerns, we agree to a condition that no access or parking shall take place on Wilton Street after midnight by staff or delivery drivers.

# 6. Surrounding Properties and Consultation

The neighbouring property at 133 Liverpool Road is a takeaway, with no known residential use above (see appendix with valuation rating list as internal store to 1st floor).

The adjoining property to the other side is a business name Evolving care which provide care home services, also non-residential. and they close 6pm

During the 28-day public consultation, no objections were received from neighbouring residents, which we believe reflects responsible and considerate operations to date.



## 7. Comparable Licensed Premises – Burslem Branch

We currently operate a Caprinos branch in Burslem under Stoke-on-Trent Council, licensed to operate until 4:00 AM.

This premises is under the same ownership as the 131 Liverpool Road branch.

That site is also adjacent to residential properties and uses the same equipment and operational model.

Since the licence was granted in August 2022, there have been no complaints or enforcement issues, which we believe demonstrates our commitment to good practice and effective mitigation.

# 8. Willingness to Accept Conditions

To support our application and show good faith, we are willing to accept the following conditions:

No customer collection permitted after 1:00 AM

Maximum upto 3 delivery drivers

Drivers to use only the A34 for arrival/departure

No use of Wilton Street after midnight

No horns, radio/music, or engine idling outside

Silencer to be installed on the ventilation fan if required

Noise monitoring system, if appropriate

Acoustic assessment of party wall with mitigation if necessary







# Alternate Conditions Proposed by Licensing Officer for Public Nuisance Objective

- The licensed premises will only use delivery drivers employed by the premises licence holder and training will be given to the drivers on a 6 monthly basis in relation to their impact on local residents with specific mention of:
  - a.) Drivers will only be allowed to use the A34 for arrival and departure.
  - b.) Drivers will not be allowed to use Wilton Street after midnight.
  - c.) Drivers must not use the horn on their vehicle when it is stationary, in greeting or frustration or between the hours of 23:00 and 07:00.

## **Mandatory Conditions**

# Mandatory Condition in Force From 28th May 2014

- 1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- For the purposes of the condition set out in paragraph 1—

   (a)"duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;.
   (b)"permitted price" is the price found by applying the formula—.

 $P = D + (D \times V)$ 

# where-

- i. (i)P is the permitted price,
- ii. (ii)D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- iii. (iii)V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- iv. (c)"relevant person" means, in relation to premises in respect of which there is in force a premises licence—
- v. (i)the holder of the premises licence,
- vi. (ii)the designated premises supervisor (if any) in respect of such a licence, or
- vii. (iii)the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e)"value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
  - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

# **Conditions Consistent with the Operating Schedule**

# PREVENTION OF CRIME AND DISORDER

- 1. CCTV must be installed and cover all internal areas. The CCTV unit shall be positioned in a secure part of the licensed premise and not within any private area of the location. Access to the system should be allowed immediately to the Police, Trading Standards or Local Authority Officers in accordance with the Data Protection Act where it is necessary to do so for the prevention of crime and disorder, prosecution or apprehension of offenders or where disclosure is required by law.
- 2. All images must be kept for a 28 day period and to be produced to the Police, Trading Standards or Local Authority Officers in relation to the investigation of crime and / or disorder issues and suspected licence breaches, upon request or

within 24 hours of such request where it is necessary to do so for the prevention of crime and disorder, prosecution or apprehension of offenders or where disclosure is required by law.

- 3. The CCTV system must be maintained so as to be fully operational and recording 24 hours every day.
- 4. The CCTV system clock must be set correctly and maintained (taking account of GMT and BST).
- 5. There must be a competent member of staff available at all times who is trained and capable of operating the CCTV system and also downloading any footage required by the Police, Trading Standards or Local Authority Officers. The Premises Licence Holder shall ensure that a written log of any incidents is kept on the premises with all details recorded of dates, times, incident, staff involved etc. Written records of incidents will be retained and shall be made available for inspection on demand by the Police or Local Authority Officer.
- 6. A written record shall be kept on the premises by the Premises Licence Holder of every person employed on the premises, in a register kept for that purpose. That record shall contain the following: a.) Date and time person starts and finishes each duty
- b.) Name, address and date of birth of each member of staff including delivery drivers c.) Record of vehicle registration numbers used in any delivery service and a copy of vehicle insurance
- 7. The employee register must be kept fully updated at all times and remain at the licensed premises and be available for inspection upon request by the Police or Local Authority Officer.





# SUPPORTING STATEMENT

Subject- Grant of Premises License for Caprinos Pizza Newcastle-under-Lyme, 131 Liverpool Road, ST5 9HD

Further to the response received from Environmental Health (dated 17th March 2025) in relation to our premises license we would like to provide some evidence to support our request for the extension of operational hours as submitted. Firstly we would like the Environmental Health team to review their objection in line with the below evidence in order for an amicable solution instead of proceeding through a formal hearing which we feel is unnecessary.

As you can appreciate due to the financial situation many businesses are facing due to increased overheads in relation to food supplies, energy bills, staffing etc it has left us no other option but to consider offering our products for the late night trade to ensure we maintain a healthy business model. Of course this has to also take into consideration our neighbours (who are also regular customers) to ensure they are happy. To date there have not been any 3<sup>rd</sup> party objections received from members of the public in regards to our proposed hours (effecting noise levels) and we have also agreed that after the given hours from our previous late night license that we would solely operate a strict delivery only service.

During the extended later hours we would not have any sort of music playing whether that be indoors or in any delivery vehicles as our aim will be utilise staff vehicles for delivery instead of 3<sup>rd</sup> party delivery providers to ensure we can control this accordingly. Our CCTV that is operational would have benefit of recording audio and we would be able to put certain measures in place to ensure staff are given strict instructions otherwise they would face disciplinary actions.



We understand that there may be some residential premises at a 36m distance from our site but our

operational hours proposed would not affect them as our delivery vehicles would be operating from

the front of the building which would block out most of the noise and also the residents would hear

more of the public highway traffic noise opposed to just our delivery driver vehicles with that being the

main road. For the orders that we do receive in the later hours of the evening these would always be

batch delivered to prevent multiple car trips in the first instance.

Nevertheless we have collated multiple examples of many premises operating either to the hours we

desire or even greater such as Mc Donald's (operational 24hrs) that have a constant flow of customer

vehicles that could be playing loud music to this time of night cited at just 21m from the nearest

residential premises.

Given this we feel the local authority needs to take a fair approach and provide us as a business like

others with an opportunity to trade during these hours and should we breach any of the conditions or

have any critical complaints in the future then this can be reviewed by yourselves accordingly to put

restrictions or sanctions in place.

We are happy to compromise on the hours to a mutually agreement as follows:

Sun-Thurs (original proposal) - 23:00-03:00am

Sun-Thurs (revised proposal) - 23:00-02:00am

Fri-Sat (original proposal) - 23:00-04:00am

Fri-Sat (revised proposal)- 23:00-03:00am





Thank you for your email regarding my application to vary the premises licence. I have carefully reviewed the Cumulative Impact Assessment (CIA) policy and the relevant guidance. I would like to outline the measures I will take to mitigate any potential impact and explain why my application should be considered an exception to the policy.

## Existing Business Operations & Low Impact on Cumulative Impact Area

My business is an existing, well-established food takeaway that primarily operates as a delivery service, with approximately 95% of orders being deliveries and only 5% collected in person.

There is no seating inside the premises, meaning customers do not remain on-site for extended periods, reducing any potential for congregation or noise-related disturbances.

The shop is located on the main A34 road, a dual carriageway, which is a busy commercial area with other businesses on both sides of the road. There are no immediate residential properties directly facing the premises.

The nearest residential properties are located approximately three houses away behind the premises on Wilton Street, not directly adjacent to or impacted by the business operations.

Measures to Mitigate Impact

## **Prevention of Public Nuisance**

<u>Minimal Walk-In Traffic:</u> Since the majority of orders are delivered, there is very little foot traffic or customer waiting outside the premises.

*No Seating, No Gathering:* Without dining space, customers collect their orders and leave promptly, ensuring there is no loitering or noise buildup.

<u>Signage & Staff Monitoring:</u> Clear signs will be displayed requesting customers to respect local residents, and staff will be trained to manage any potential disturbances.

Traffic & Noise Management.

<u>Dedicated Parking in Front of the Shop:</u> Delivery drivers park in our designated parking area directly in front of the shop, minimizing traffic congestion and noise spillover into residential areas.

No Impact on Residential Streets: Delivery drivers use only the A34 dual carriageway for transport, avoiding small residential streets and ensuring there is no direct noise impact on nearby homes.

## **Crime Prevention & Security**



<u>CCTV Coverage:</u> The premises is covered by high-quality CCTV monitoring both inside and outside, with recordings retained for 30 days, accessible to the police and council if required.

<u>Well-Lit & Monitored Area:</u> The business is situated in a commercial zone with good street lighting and active business activity, reducing the risk of crime or disorder.

# Why This Application Should Be an Exception

While I appreciate the Licensing Committee's concerns regarding cumulative impact, my premises operates in a way that differs from high-risk businesses such as bars, pubs, or late-night restaurants. The key reasons why this application should be considered an exception include:

<u>Predominantly Delivery-Based Business:</u> With only 5% collection orders, the business does not contribute to high foot traffic or customer congregation in the area.

<u>Minimal Impact on Local Residents:</u> The nearest homes are located at the back on Wilton Street, and all business-related traffic remains on the A34 main road, a busy commercial dual carriageway with no direct residential impact.

<u>Strict Noise & Traffic Management:</u> Dedicated parking, controlled customer flow, and a delivery-focused model ensure no additional strain on local infrastructure or noise pollution in residential areas.





### What is Cumulative Impact?

Cumulative impact is "the potential impact on the promotion of the licensing objectives of a number of licensed premises concentrated in one area." For example where there is a high density of licensing premises selling alcohol or supply hot food that may give rise to crime and disorder or nuisance.

### **Background**

The concept of "Cumulative impact" has been described within the s.182 Licensing Act 2003 Guidance and used by licensing authorities within their statements of licensing policy (SLP) since the commencement of the 2003 Act. 'Cumulative impact assessments' were introduced in the 2003 Act by the Policing and Crime Act 2017, with effect from 6 April 2018. In general terms and effect they replaced Cumulative Impact Policies (CIP), however there was no statutory transition or conversion process.

A cumulative impact assessment (CIA) may be published by licensing authorities to help them limit the number or types of licence applications granted within a specified area. They can do this where there is an evidential basis that the number or density of licensed premises in the area is having a cumulative impact and leading to problems which are undermining the licensing objectives. CIAs relate to applications for new premises licences and club premises certificates and applications to vary existing premises licences and club premises certificates in a specified area.

Before adopting a CIA the authority must establish the evidential basis that one is required, and consult upon its scope and extent with the same persons that must be consulted over the SLP.

### **Cumulative Impact Assessment Details**

A consultation was undertaken between March and April 2024. Following the consultation period, having received evidence from Staffordshire Police and the Council's Environmental Health department, the Licensing Committee (the Committee) determined that there was an evidential basis to implement a CIA and extend both the area and scope to be covered.

The area covered by the previous CIA has been extended. The plan of the new area is attached at **Appendix A**. The assessment will relate to all premises and business types within the specified area that have a premises licence or a club premises certificate which will be carrying on or proposing to carry on the following licensable activities:

- The sale or supply of alcohol on or off the premises;
- The provision of late night refreshment
- The provision of any regulated entertainment

The Committee came to this decision following statistical data provided by Staffordshire Police showing that levels of crime and Anti-Social Behaviour had reduced in 2023-24 from 2022-23, however it had not reduced to the levels seen pre and during the pandemic in the area known as the 'Town Centre'. They also stated that the CIA was a key tool in supporting the licensing objectives and in helping keep the area a safe place to live, work and visit. Additionally, it is the Police's view that

without a CIA it may lead to a proliferation of licensed premises which would likely have a detrimental effect on the safety of the town.

The evidence provided by Staffordshire Police and the Council's Environmental Health department suggested that premises that offer, or propose to offer, late night refreshment may add to the cumulative impact of premises within the night time economy and those premises should be included.

The Police data provided covered the three periods detailed below and relates to Crime and Antisocial behaviour. The data that relates to the 'Town Centre' is attached as **Appendix B**, and the data for the Whole Borough is attached as **Appendix C**:

- April 2021-March 2022
- April 2022-March 2023
- April 2023-March 2024

The Committee decision was that to grant any further premises licences or club premises certificates, or variations of existing permissions, within the area detailed in Appendix A, would be inconsistent with the authority's duty to promote the licensing objectives.

#### **Assessment of Applications**

The evidence underpinning the publication of this CIA will generally be suitable as the basis for a decision to refuse an application or impose conditions. However it does not change the fundamental way that the Council must make decisions under the 2003 Act. Therefore, each decision subject to the CIA still needs to be made on a case-by-case basis and with a view to what is appropriate for the promotion of the licensing objectives. Importantly, the publication of this CIA does not remove the Council's discretion to grant applications for new licences or applications to vary existing licences, where they are considered appropriate in the light of the individual circumstances of the case.

In publishing this CIA the Council is setting down a strong statement of intent about its approach to considering applications for the grant or variation of premises licences or club premises certificates in the area described. The Council must have regard to the assessment when determining or revising its SLP. It is therefore expected that, in respect of each relevant application in the area concerned, the licensing authority will be considering whether it is appropriate to make a representation to its committee as a responsible authority in its own right. As stated above, the CIA does not change the way that licensing decisions are made. It is therefore open to the licensing authority to grant an application where it considers it is appropriate and where the applicant can demonstrate in the operating schedule that they would not be adding to the cumulative impact. Applications in areas covered by a CIA should therefore give consideration to potential cumulative impact issues when setting out the steps that will be taken to promote the licensing objectives. Where relevant representations are received and a licensing authority decides to grant an application it will need to provide the applicant, the chief officer of police and all parties who made relevant representations with reasons for granting the application and this should include any reasons for departing from their own policy.

This CIA does not relieve responsible authorities (or any other persons) of the need to make relevant representations where they consider it appropriate to do so for the promotion of the licensing

objectives. Anyone making a representation may base it on the evidence published in the CIA, or the fact that a CIA has been published. However, it remains incumbent on all responsible authorities and other persons to ensure that their representations can withstand the scrutiny to which they would be subject to at a hearing. As with all licensing applications under the 2003 Act, if there are no representations, the licensing authority must grant the application in terms that are consistent with the operating schedule submitted.

Whilst this CIA does not apply directly to Temporary Event Notices, the Secretary of State's Guidance to the Licensing Act 2003 states that it is open to the Police and Environmental Health officers to refer to this assessment and the evidence contained within it when objecting to a TEN. The authority believes this is a right and proper approach as extension of hours within the Cumulative Impact Assessment Area can have a direct impact on the promotion of the licensing objectives.

#### **Review of the CIA**


This CIA is a standalone live document and is capable of being amended, following the required consultation process and without the need for the Council to review and consult upon the SLP document.

The licensing authority must, within three years, consider whether it remains of the opinion set out in this assessment. In order to decide whether it remains of this opinion it must again consult the appropriate persons. If having consulted the Council decides that it is no longer of the opinion set out in the CIA, it must publish a statement to that effect. The statement must make clear that any reference to the CIA in its licensing policy statement no longer applies. The licensing authority should remove any reference to the CIA within its SLP at the earliest opportunity.

If having consulted the Council decides that it remains of the opinion set out in the assessment, it must revise the CIA to include a statement to that effect and set out the evidence as to why it remains of that opinion. It will be important for any evidence included in the revised CIA to be robust and relevant to the current problems described. This will likely involve the collation of fresh or updated evidence of cumulative impact. The Council must also at this stage publish any other material change to the assessment. For example if the types of premises or area described in the assessment have changed due to a shift in the nature of the problems being experienced, or where there is evidence of the emergence of a new type of problem.

In each case the three year period for reviewing a CIA begins with the original date of the publication of the CIA or the date that a CIA was last revised. Where the SLP as a whole is due for review, under the five year review period under the Act and this occurs before the end of the three year CIA review period, the Council may use this as an opportunity to carry out a review of the evidence in support of the CIA. However, the Council is free to carry out consultations and reviews of the CIA (and/or SLPs) at more regular intervals if considered appropriate.




